General Information

Invitation

The goal of SCASLA is to strengthen the profession by promoting the works of landscape architects in the state of South Carolina. In order to promote and recognize the value of landscape architecture, the annual SCASLA design awards will be given to recognize excellence in the design profession. Recognitions will be made at the SCASLA Annual Conference in September 2022.

Eligibility

Award submissions are open to projects or to ASLA Members, Associates, and Fellows in South Carolina. This includes Faculty members, and Students currently teaching or enrolled in landscape architecture programs within the state. Applicants for student awards must be the student who performed the work or students from a team that performed the work. Student projects must have been performed while enrolled at an accredited university in South Carolina and may be submitted up to one year post graduation. Professional entries are accepted from private practice, public agencies, non-profit, local, state, and federal government entities. Entries from other professions are accepted pending pre-approval by the Awards Chair. Professional entry applicants must have express permission from the firm responsible for the work.

SCASLA retains the right to disqualify any entry that does not meet the program requirements or that presents a conflict of interest. In such case, refunds will not be issued.

Jury/Award

A project may be resubmitted until it wins an award at the state level. The awards will be juried by a peer ASLA Chapter. Identities of the entrant and creative team are not revealed to the jury, and members of the professional awards jury, as well as the firms, organizations, agencies, or employers they represent are not eligible to enter the professional awards program.

The jury will consider the quality of design; execution of built work; likelihood of successful implementation and significance of unbuilt work; context; environmental sensitivity and sustainability; hazard mitigation, climate adaptation, and resilience strategies; and design value to the client, community, and other designers.

Award Levels

Awards will be given based on the merits of the project for the Category submitted. The decisions of the jury are final and solely based on the submission.

Possible Award Categories include:

- Award of Excellence: Awarded for innovative solution that goes beyond project purpose. One Award per Category may be given if merited.
- Honor Award: Awarded for outstanding, imaginative, and well resolved solution. Any number of entries in each Category may receive this award, if merited.
- Landmark Award: Recognizes a distinguished project completed between 15 and 50 years ago that retains its
 original design integrity and contributes significantly to the public realm of the community in which it is located.
 The jury may select one recipient, if merited.

Entries will be judged on quality of design or presentation, functionalism, context and surrounding relationships, technological advancements, pioneering efforts, and overall significance to the profession.

Categories

Professional Awards will be given for General Design, Residential Design, Analysis and Planning, Urban Design, Communications, Research, and Landmark projects.

Student Awards will be given for General Design, Residential Design, Analysis and Planning, Urban Design, Communications, Research, and Student Collaboration, and Student Community Service projects.

Deadline/Fees

Entry form, entry fee (PayPal or check) and submission must be received no later than: *July 28, 2022 at 5:00pm*. All entry fees must include the appropriate entry fee at time of submission or will not be considered for judging.

Submission Categories

Categories

Select only one of the following categories for your entry:

- A. GENERAL DESIGN Site-specific works of landscape architecture. Entries in this category must be built. Typical entries include: single-site public, institutional or private landscapes of all kinds (except entries qualifying for urban design or residential design categories); historic preservation, reclamation, or conservation; green roofs, stormwater management, sustainable design, design for transportation or infrastructure; landscape art or installation; interior landscape design; and more. Student projects may be entered in this category. Student entries are not required to be built.
- B. RESIDENTIAL DESIGN Site-specific works of landscape architecture for single and multifamily residential use that elevate the design principles of quality, context, environmental responsibility, maintenance requirements, and durability. Innovative design and construction techniques that help reduce overall construction and maintenance costs will also be recognized. Entries in this category must be built. Typical entries include: single family homes; high rise, multi-family production and custom home developments (market rate and non-market rate will be considered); transit oriented development (TOD); historic preservation, renovation or conservation projects; senior or assisted living developments; private or small gardens; new urbanism projects with multifamily development; projects located in Opportunity Zones; and more. Student projects may be entered in this category. Student entries are not required to be built.
- C. URBAN DESIGN Site specific projects that activate networks of spaces that mediate between social equity, economic viability, infrastructure, environmental stewardship, and beautiful placemaking in the public and private realm. Entries in this category must be built or currently under construction. Typical entries include: urban projects greater than one block in the realm of public, institutional, or private landscapes; streetscapes, waterfronts, mixed-use developments, neighborhoods, districts, cities, placemaking interventions and civic interventions that may include elements of reclamation, stormwater management, transportation or infrastructure studies, art, and more. Student projects may be entered in this category.
- D. ANALYSIS AND PLANNING The wide variety of professional activities that lead to, guide, and evaluate landscape architectural design. Entries in this category are not required to be built or implemented. Typical entries include: urban, suburban, rural, or regional planning efforts; development guidelines; transportation, town, or campus planning; plans for reclamation of brownfield sites; environmental planning in relation to legislative or policy initiatives or regulatory controls; cultural resource reports; natural resources protection; historic preservation planning; and more. Student projects may be entered in this category.
- **E. COMMUNICATIONS** Achievements in communicating landscape architecture works techniques, technologies, history, or theory, and the lesson value to an intended audience. Typical entries include: print media, film, video, audio, CD, or DVD formats; online communications; interpretive design; exhibition design; and more. If media resides online, applicants are encouraged to provide an ad-free link in their submission. *Student projects may be entered in this category.*
- **F. RESEARCH** Research that identifies and investigates challenges posed in landscape architecture, providing results that advance the body of knowledge for the profession. Typical entries include: investigations into methods, techniques, or materials related to landscape architecture practice or education; assessments of social, economic, or environmental impacts of landscape architecture; study of relationships of landscape architecture to law, education, public health and safety, or public policy; and more. *Student projects may be entered in this category*.
- **G.**THE LANDMARK AWARD A distinguished landscape architecture project completed between 15 and 50 years ago that retains its original design integrity and contributes significantly to the public realm of the community in which it is located. Typical entries include: built landscape works may include parks, plazas, gardens, river walks, of all kinds. This category can be submitted by any organization, public officials, or agency. Student projects are <u>not eligible</u> for this category.

Entry Submission Requirements

Submission Form and payment information are contained on the SCASLA website (https://www.asla-sc.org). Submission Items shall be submitted via email; payment shall be submitted via check or Paypal as described on the SCASLA website. Multiple projects can be submitted by the same applicant but must be submitted individually. Please direct all email submissions or questions to awards@scasla.org
NOTE: Upon notification, Award Winners will be required to submit winning project in JPEG files of site photos, site plans, and project documentation within the requested time frame for inclusion in the Awards Ceremony Presentation.
